Please fill in all information requested on the application form. Acceptance will be based on the description of your menu and one photo of your booth. Photo should be clearly labeled on the back with your name and phone number. *Applications must include a self-addressed, stamped envelope for show status notification. Only complete applications will be considered.*

Acceptance is contingent upon the approval of the Coconino County Health Department and the Flagstaff Fire Department.

DEADLINE FOR ENTRY IS MAY 1, 2012.

Entries will be taken on a first come, first served basis until available food spaces are full. All spaces will be preassigned. All fees must accompany your application. The **application fee is \$15** and the **Booth fee is \$450** for a 10' x 10' space, and will be cashed only upon the artist's acceptance into the festival. This fee includes water. Electricity is an additional \$35. The sale of certain beverage products will be coordinated through our sponsor.

If you have a current City of Flagstaff Sales Tax License include the number on this application. If you do not have a current license the city requires you to submit a sales tax fee in advance. Please enclose \$15 for this fee, which you can offset by collecting city sales tax during the show.

YOU ARE ALSO RESPONSIBLE FOR ARIZONA STATE SALES TAX

There is a \$25 charge for returned checks. Please make check payable to Flagstaff Art In The Park. *Late entries will be considered, if there is space, at an additional \$25 fee.* No refunds will be given after June 1. All spaces are approximately 10' x 10'. Setup will begin at 6 AM on July 6th, and the show will run from 9 AM to 6 PM on Friday and Saturday and 9 AM to 4 PM on Sunday. Canopies or trailers are required.
